ADSL STORY

The Associates for Development Services Limited (ADSL) was established in 1999 in Bangladesh with humble beginnings. With little more to show than a determination to achieve significant results, the organization has since gone on to become an important player in the development consulting services arena.

ADSL offers a range of technical advisory services to multilateral, bilateral, governmental, and non-governmental organizations based both in Bangladesh and abroad. The organization addresses social and economic constraints while seeking opportunities for poverty reduction and sustainable development. Its expert consultants identify and implement appropriate action plans to reduce economic barriers and build on opportunities.

ADSL has crafted a reputation for itself thanks to its expert knowledge and ability to successfully implement projects in the sectors of social development, economic growth, infrastructure, institutional support, and governance. The organization provides its clients with tailored consulting advice and appropriate approaches drawn from cases originating from various countries. It adapts these practices to the scenarios at home, working closely with local experts to achieve results.

ADSL has developed its in-house capacity over the years and has created a network of experts dedicated to providing quality services. The organization has worked on projects in Azerbaijan, Bangladesh, India, Pakistan, Mongolia, Sri Lanka, and Vietnam and is registered with the World Bank (its vendor ID no. being 91678) and the Asian Development Bank (its CMS number being 002514) as a consulting firm. **ADSL is also an ISO 9001:2015 certified company.** In addition, ADSL provides consulting services to projects supported by international organizations such as the Asian Development Bank, the World Bank, the International Finance Corporation (IFC), the Department for International Development, the European Commission, the Japan International Cooperation Agency, and more.

ADSL TEAM

The ADSL team is comprised of technical and administrative staff, with the responsibility of overall management resting on the shoulders of the Board of Directors. All the Directors boast illustrious careers and are renowned in their relevant sectors. ADSL concentrates on quality and timely completion of projects, having a pool of qualified senior associates in different disciplines on call to be utilized at all stages of project management as and when needed. The organization has a Project Management Unit (PMU) that enables a one-point communication platform for clients and consultants alike. In addition to its core staff and associates, ADSL maintains close ties with professional, academic, and research institutions both within and outside the country.

Its integral role in the development sector has been increasing significantly over the years and numerous noteworthy resource persons in Bangladesh and beyond have worked with ADSL efficiently with the utmost satisfaction.

ADSL's Board of Directors is comprised of the following individuals: Managing Director Mr. Md. Golam Kabir; and Directors Ismail Hossain Patwary and Zahidur Rahman. The Board of Directors is supported by competent in-house professionals and support staffs in the regular payroll of ADSL comprising of 5 directors, 4 engineers and 25 staffs for business development as well as effective implementation of the consulting assignments. The directors have worked in public and private sectors and with INGO and development partners with long experience and expertise in development planning, public administration, finance, project design and implementation. Currently, about 100 professionals, including 36 engineers, are

working in 13 development projects/consulting assignments being implemented by ADSL in association with other national and international agencies. In addition, depending on the nature of a particular assignment, ADSL brings together the services of specialists and additional supporting staff from its pool of associates and roster of consultants, including international experts across the regions.

WHAT WE DO



In addition to its main market in Bangladesh, the organization has implemented projects in Azerbaijan, Sri Lanka and Mongolia with plans to initiate more ventures in other developing countries in the South Asian region. ADSL provides a wide range of short and long term technical advisory services through international and national experts who participate in missions, projects, programs and studies. Some of the important services that ADSL engages in are outlined below.

- ❑ **Project Identification, Appraisal and Formulation:** As the first step in the strategic planning process, ADSL identifies the feasibility of a project before devoting significant time and resources to its implementation. With this initial assessment complete, the organization then examines the viability of the project more closely – appraising the benefits of proceeding with the venture. Next, in the Project Formulation stage, ADSL identifies the scope of work associated with the project and estimates the expected costs to be incurred as part of the project’s activities.
- ❑ **Project Management and Implementation:** As part of its Project Management service, ADSL uses its skills and experience and knowledge of processes and methods to achieve project objectives. In this context, a project can be defined as a unique venture undertaken to attain planned objectives, which can be defined in terms of outputs, outcomes or benefits. In the Project Implementation stage, ADSL puts all its visions and plans into action. At this stage, all the activities described in a work plan are carried out, involving the coordination of a wide range of activities, the overseeing of a team and the management of a budget among other issues.
- ❑ **Human Resource & Capacity Building:** For ADSL, Human Resource Capacity Building means much more than simply providing training. It means equipping individuals with the understanding, skills and access to knowledge that enables them to perform effectively, while looking into management structures, processes and procedures that will enhance their productivity. ADSL recognizes that the need for capacity building is always changing and that any program addressing it must be suited to the local context and organization.
- ❑ **Monitoring and Evaluation:** The purpose of ADSL’s Monitoring and Evaluation system is to provide accurate and timely information related to the company’s various interventions and projects so that management at all levels of decision-making can determine what made an initiative a success or a failure. Furthermore, the monitoring and evaluation system brings to light what lessons can be applied when implementing future projects. By determining what worked and what did not in a

project, better decisions will be made and resources will be allocated more efficiently for future ventures.

OUR MARKET

Since its establishment ADSL has worked in different areas of activities in various markets and sectors, expanding its expertise and cementing its position as an invaluable multi-sector consulting company. This section highlights the important work ADSL has conducted in different markets across Bangladesh.

- ❑ **Urban Infrastructure:** ADSL provides support to physical infrastructure projects initiated by the government, mainly under the leadership of the Local Government & Rural Development directorate. The organization fulfills planning and quality assurance roles when undertaking projects with partners in this sector. In the past, ADSL has reviewed the European Commission's support to Bangladesh for disaster preparedness. Furthermore, the organization has experience evaluating coastal embankment rehabilitation programs and strategies for city development aimed at poverty alleviation.
- ❑ **Rural Infrastructure:** ADSL's engineers, M&E specialists and gender experts have been working alongside its associate firms with the Ministry of Chittagong Hill Tracts Affairs to implement a six-year area development program supported by the Asian Development Bank. ADSL is part of a team dedicated to bringing economic opportunities and proper physical infrastructure to the region in a sustainable and efficient way – thereby playing an important part in improving the livelihood of those living in the area.
- ❑ **Regional Development:** ADSL is now preparing and implementing the “Haor Flood Management and Livelihood Improvement Project” alongside the Government of Bangladesh with funding provided by JICA. The goal of this project is to manage the recurrent flooding which takes place in the Haor (back swamp) regions of the country and to enhance the area's living standards through livelihood improvement interventions. The project will be implemented in twenty-nine Haor area stretches in five districts, namely Sunamganj, Habiganj, Netrokona, Kishoreganj and Brahmanbaria in the northeast of Bangladesh.
- ❑ **Renewable Energy:** ADSL has been an emerging player in the renewable energy market in Bangladesh. In the recent years, it has contributed various clients by assessing the needs and programming interventions so that the country can be positioned onto the right launching pad for emerging renewable market. It has recently been involved among other, waste-to-energy (Danida), sustainable energy (The World Bank), and Renewable energy and energy efficiency program (GIZ).
- ❑ **Climate Change:** ADSL has implemented a number of climate resilience projects. From the years of experience in implementation and supporting implementation of projects both at urban and rural contexts; it has acquired solid expertise in climate resilience, mitigation and adaptation projects. The key areas of expertise included review policy, regulatory and institutional framework for emergency and environmental matters; monitoring and evaluation of climate change impacts on the livelihoods of people in urban and rural settings; mechanism for identifying and validating issues, opportunities and alternatives; design and implementation of climate resilient infrastructures, ensuring that climate resilience principles are adequately considered; and updating master plan of selected municipality towns mainstreaming climate change mitigation and adaptation measures. For example, (i) ADB funded technical assistance project TA-8913WEG: subproject 1 developing integrated urban development plan in selected DMC cities incorporating urban climate resilience principles, (ii) Rapid Strategic Environmental Assessment of the Waste of Energy Engagement (W2E) of the Danida supported climate change adaptation and Mitigation Program (CCAMP) in Bangladesh.
- ❑ **Education:** ADSL offers extensive services in the education sector, particularly in the area of human resource development and its management from primary to tertiary levels. The organization has substantial experience in non-formal post-literacy programs and continuing education. It is currently in partnership with Sweco, Denmark working with the Ministry of Education and the Directorate of Secondary and Higher Education to implement the Secondary Education Sector Investment Program (SESIP) with

project funding provided by Asian Development Bank. The overall objective of SESIP is to reduce poverty in Bangladesh by establishing a more relevant secondary education in terms of quality, efficiency and equity through developing the secondary education sector as a whole. Together with same consortium, it is also involved in implementing ADB funded Second Teaching Quality Improvement Project.

- ❑ **Health:** ADSL has provided its services in both macro and specialized settings in the health sector. It has contributed to the formulation of the country's National Health Policy with the partnership of the Health, Nutrition and Population Sector Program (HNPS). The organization has also delivered diverse health related projects, from an urban primary healthcare project in association with the Asian Development Bank to a demand side health financing and voucher scheme in partnership with the European Commission. Apart from policy formulation and project preparation, ADSL has conducted studies to assess the impact of numerous health related interventions.
- ❑ **Water Supply and Management:** ADSL has entered a partnership with Mott MacDonald to work with Dhaka Water Supply and Sewerage Authority (DWASA), in an ADB supported project, to implement the Dhaka Environmentally Sustainable Water Supply project (DESWSP) and Saidabad Water Treatment Plant Phase III, supported by AFD and KfW. This project aims to supply the city of Dhaka with reliable and sustainable water by developing a new surface source to replace the decreasing groundwater supply. ADSL's responsibility includes supporting the Project Management Unit in overall project management and implementation, ensuring that all works are carried out in accordance with Asian Development Bank standards such as its environmental and social safeguards requirements.
- ❑ **Private Sector Development:** ADSL provides institutional services in private sector development. The services include institutional strengthening and management as well as human resource development. Furthermore, the organization offers services in project management and administration. The aim of providing these services is to facilitate the process by which associated projects promote economic growth and reduce poverty by building private enterprises.
- ❑ **Public Financial Management:** Along with partner firms Ecorys and PMTC, ADSL has worked with the Planning Commission of Bangladesh to break down macro level outputs from the country's 6th Five Year Plan to actionable measures that are easier to link with development projects. The organization assisted the partner firms in strengthening appraisal, approval and monitoring mechanisms, which in turn assisted in the implementation of effective budget development strategies – leading ultimately to better governance and accountability.
- ❑ **Trade and Industry:** ADSL has made great strides in the field of trade and industry, providing technical capacity support in projects aimed at fine tuning Bangladesh's trade regime. The organization is building the capacity of relevant trade bodies by providing policy support and capacity development programs with the aid of WTO research and the formation of integral partnerships. For example, ADSL is currently engaged in a European Commission supported trade policy program with Bangladesh's Ministry of Commerce and the Export Promotion Bureau with the goal of formulating a comprehensive trade policy for the country.
- ❑ **Governance:** ADSL is actively involved in improving systems of governance, both at local government bodies and the central government. With support from JICA, ADSL is currently working with IC Net of Japan, in implementing "National Integrity Systems Implementation" Technical Assistance, in collaborating with the Cabinet Division of the Government of Bangladesh. In addition, it is also working with Nippon Koei and IC Net, with support from JICA, with a view to supporting Local Government Division to implement "Upazila Governance and Development Project".

Quality Control System

When evaluating whether one of its projects is successful, ADSL measures its performance against quality standards to determine whether the organization is meeting its expectations. Having an effective quality

control system can reveal the weaknesses in a process, allowing prompt action to be taken to rectify areas of deficiency. The significant features of ADSL's quality control system are described below.
